Scope of Works

Top Front Roof

- Remove asbestos barge cappings.
- Wrap and seal.
- Dispose of at accredited waste facility.
- Remove metal roof sheeting flashings and cappings.
- Remove old gutter and downpipes.
- Supply and install new 55mm foil backed roof blanket insulation.
- Supply and install new 0.24 Zincalume kliplok 700 style roof sheeting.
- Supply and install new 0.55 Colorbond barge cappings
- Supply and install new square style slotted Colorbond gutter and 2 x new 100 x 75mm Colorbond downpipes.

Rear Lower Tile Roof

- Remove old roof tiles and cappings.
- Supply and install new 40mm metal roof battens.
- Supply and install new 55mm foil backed roof blanket insulation.
- Supply and install new 0.42 Colorbond corrugated roof sheeting.
- Supply and install new Colorbond roll top ridge cappings.
- Supply and install new 0.55 Colorbond custom flashings to suit.

Inclusions

- Roof rail edge protection while works are in progress.
- Use of site power.
- Skip Bins.
- Waste removal.

Exclusions

- Gutters & downpipes on lower tile roof.
- Disconnection or re connection of any solar services (If Required)

Price Quoted

The price quoted stands for 30 days from date of quotation.

Damage to Roads, Drives, Foot Paths and Gardens

During the works in some cases we may need to place cranes, ewps, bins, Scaffold and other machines or equipment on the above surfaces. If we have not been provided information on the load capacity of the surface there may be damage to them. Our offer does not include costs associated with their repair and/or replacement as a result of any of this work being conducted.

Klip-Lok Products

If a Klip-Lok type product is to be installed in a re-roof application, we may need to crest fix the ribs at the gutter line.

After Practical Completion

After practical completion of the work, it is the responsibility of the controller of the premises to ensure safe access to and from the roof including any anchor points on the roof where required.

Electrical Cables

Any electrical cables which run illegally over battens and purlins or are in a location where a roof screw can come into contact will not be repaired by Kimick Roofing Solutions if so damaged.

Warranties

All new work is guaranteed 2 years workmanship and manufacturers warranties on products used.

For Minor works under \$20,000 the Statutory Warranty of 2 years on minor defaults and 6 years on major defaults under the Fair Trading acts apply.

Home Owners Warranty Insurance for works over \$20,000 is available at the cost of the client. Please let us know if you would like a costing for this.

Works

All works carried out in a tradesman like manner and freed from all trade waste upon completion.

Works will comply with the Building Code of Australia Act and Standards.

The liability of the contractor will be limited for failure to comply where

- i) a design or specification prepared on behalf of the homeowner (and not the contractor).
- ii) a design or specification required by the homeowner if the contractor has advised the home owner in writing that they go against the work compliance clause.

Variations
